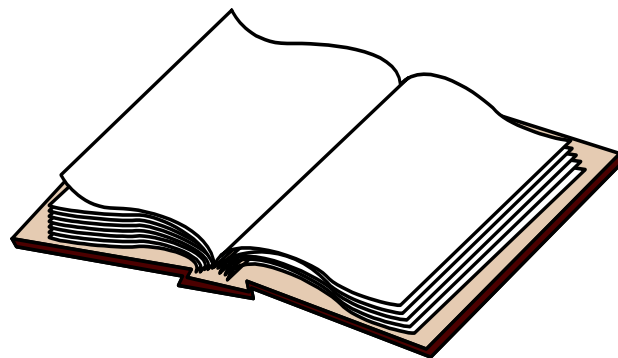
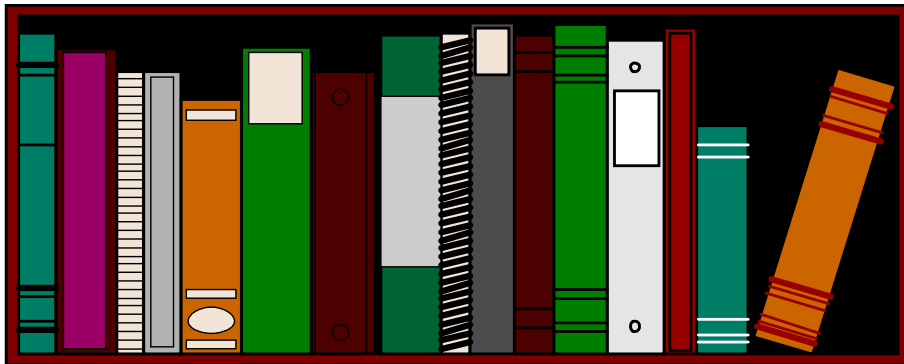

## **HCFA OASIS Outcome and Assessment Information Set Implementation Manual 7/2001 revision**

This manual is for use by home health agencies implementing the Outcome and Assessment Information Set (OASIS) as part of their patient-specific comprehensive assessment. This implementation is occurring in the context of a modification to the Medicare Conditions of Participation (CoPs) promulgated by the Health Care Financing Administration (HCFA) in two new rules. The 600 page manual is expressly written for HHA agency staff who will be implementing the use of OASIS as a uniform core data set for patient assessment and outcome measurement followed by computerization and reporting of OASIS data to the State agency.
